• Municipal Liquor Store Manager's Report

Municipal Liquor Store Manager Jenn Seegert reported a Halloween Party occurred on 11/01/2024 starting out the month nicely. Tom & Jerry Party is scheduled for December 13th.

The Council reviewed the Operating Statement for the month of October 2024 with a net profit of \$1,818.31 and a year-to-date net profit of \$42,430.46 compared to 2023 with a net profit \$2,875.11 and a year-to-date net profit of \$69,767.63.

Councilmember Wilcox made a recommendation to accept the October 2024 Liquor Store Operating Statement; seconded by Councilmember Lahmayer and carried unanimously.
